Old Business:

New Business:

 - Mr. Nelson to manage name tags, snacks

 - Mr. Keefe to survey residents on participation for food estimates
 - o Mrs. Hilson to work the welcome table
 - Mr. Coleman to draft 1-page summary of bylaws for distribution must be reviewed and approved in advance by the board
